

To receive continuing education (CE) credit, nurses, social workers, and chaplains **must be present for each full day of training (no partial credit will be given)**. Downloadable CE certificate is available upon completion of the evaluation. CE certificates for the classroom portion of the training are available online upon completion of the evaluation. CE certificates for online courses are awarded upon completion of the three-module set.
