A warm welcome to our guests traveling from abroad. Please ensure you have the correct travel documents to enter Canada.

We strongly encourage you to begin this process early, as visa and eTA applications can take several months to process due to security checks and application volumes.

To plan your travel:

1. **Check your requirements.** Depending on your passport, you may need either a **Visitor Visa (Temporary Resident Visa)** or an **Electronic Travel Authorization (eTA)** to enter Canada. Please check the official Canadian government website to confirm which document you require.
2. **Request an invitation letter (if needed).** If a formal letter of invitation is required for your visa application, please contact us at the [CPSA Office](#) to request one. Please note that an invitation letter does not guarantee visa approval.
